Dixon Lake Weir Project

Yellow Creek Waterworks Repair

364/22 Hawreschuk

WHEREAS, a power outage at the Yellow Creek Wellhouse resulted in turbidity levels to increase such that Water Security Agency issued a Precautionary Drinking Water Advisory (PDWA) effective October 1, 2022.

WHEREAS, in 2020 the green sand filters were evaluated for replacement by having a core sample conducted which did not result in media replacement at that time.

WHEREAS, the power outage may have saturated the media with potassium permanganate preventing it from being effectively regenerated.

BE IT RESOLVED, that Council immediately authorize the following expenditures:

- replacement of two (2) filter media \$6,322.30 plus applicable taxes (commencing with one (1) filter and assessing water quality); and
- hydrovac services, as required.

Yellow Creek Waterworks Consultant

WHEREAS, the Yellow Creek Waterworks continues to fall below the minimum primary disinfection requirements and the new limits of Manganese and Arsenic.

WHEREAS, the annual inspection of the Yellow Creek Waterworks as conducted by Water Security Agency in May, 2022 resulted in a required submission of a written plan on how regulatory compliance will be achieved, by September 1, 2022, and that such plan must be prepared by a qualified engineer.

WHEREAS, in order to assess the effectiveness of the recently installed aeration system an extension to January 1, 2023 has been granted.

WHEREAS, ECO Engineering Ltd. provided a proposal to prepare such plan with a delivery schedule by November 25, 2022.

WHEREAS, a current application intake is open for the Investing in Canada's Infrastructure Program (ICIP) Green Infrastructure Steam (e.g. waterworks) until November 29, 2022.

BE IT RESOLVED, that Council approve the Yellow Creek Water Plant Upgrade proposal from *ECO Engineering Ltd.* at a total cost of \$9,300.00 plus applicable taxes;

AND THAT, in accordance with said proposal, Administrator Beaulieu be authorized to immediately prepare payment to ECO Engineering Ltd. in the amount of a 30% deposit (\$2,979.72).

Rhona Lake Beach Survey

WHEREAS, in August, 2022 a survey was issued to landowners at Rhona Lake within the RM of Invergordon and the RM of Three Lakes.

WHEREAS, this survey was also issued to the Council of the RM of Three Lakes and surrounding RM of Invergordon landowners who may be impacted by the development of a public beach on Rhona Lake.

WHEREAS, the survey requested input on a proposed public beach on MR1 of the Rhona Lake Valley Estates development on the basis of "in favor" or "against".

WHEREAS, from the total of 101 surveys issued, Administrator Beaulieu received 62 responses.

WHEREAS, of those 62 responses: 26 were in favor (42%), 36 were against (58%).

WHEREAS, the Council of the RM of Three Lakes does not support the development of a public beach as proposed.

WHEREAS, from the responses received the major concerns raised were an increase in local traffic, adding recreational pressure to the lake, environmental impact, lack of washroom facilities, garbage and litter, vandalism and noise.
