ISC Services Policy Revision

WHEREAS, the process of transferring a property title is challenging for landowners to undertake on their own.

WHEREAS, property title transfers within rural residential areas (e.g. hamlets) are often low valued wherein more would be spent on legal fees than the property itself if the sale were finalized through a lawyer.

WHEREAS, RM Administration staff is well versed in processing these transfers and does so electronically so as to complete them expeditiously.

WHEREAS, Revision 1 to GG-010 ISC Services Provided Policy has been presented, as follows:

- Staff is permitted to perform title transfer services of private property residing in the RM at a rate of \$50.00 for titles valued up to \$1,000 and \$100.00 for titles valued above \$1,000;
- Staff is permitted to perform other title services (e.g. consolidations, parcel ties) on property residing in the RM at an hourly rate of \$50.00;



- The following conditions shall apply:
 - Seller must make an appointment with the RM Office to sign paperwork;
 - o Seller must have a signed Bill of Sale from the buyer;
 - Bill of Sale must include full name(s), mailing address and contact information for buyers, the settlement of arrears, payment of current year taxes and payment of all fees relating to the title transfer.
